5. On a point raised by Mr. Abdul Akbar Khan, MPA under rule 52E of the Rules enforce, not more than two calling attention could be taken up on one day. He moved the motion that for the current session rule 52E may be suspended and Mr. Speaker may be allowed to take call attention notices as many as possible.

7. On a point of order raised by Mst: Nighat Yasmin Orakzai, MPA that the contract employees from various part of the province gathered in front of press club and some of them are protesting out side the Assembly for their employment, which was supported by Mst: Shazia Aurangzeb, MPA.

Mr. Abdul Akbar Khan, MPA informed the House that he presented a Bill for the regularization of the contract employees which is pending before the Select Committee and the meeting is awaited for the Chief Minister because who is the Chairman of the said Committee being Minister Incharge of Establishment Department. He also informed that under rule 89, in the absence of the Minister Incharge the Deputy Speaker shall be the Chairman of the Select Committee. Therefore he requested the Chair that Deputy Speaker may be allowed to preside over the meeting of the Select Committee. The Speaker has given the ruling that due to heavy load of work on the Chief Minister. Therefore the Deputy Speaker may preside the meeting of the Select Committee.
9. On behalf of Minister for Housing, Minister for Law, Parliamentary Affairs and Human Rights moved the motion that the Defence Housing Authority Bill, 2008 introduced in the Provincial Assembly of NWFP on 19/08/2008 may be withdrawn under rule 107(1). The House allowed the motion.
10. Minister for Mineral Development and Technical Education, moved that the NWFP Province Sarhad Development Authority Mineral Wing (Taking-Over) Bill, 2008 introduced in the Provincial Assembly of NWFP on 29/08/2008 may be withdrawn under rule 107(1). The House allowed the motion.
