

PROVINCIAL ASSEMBLY OF NWFP

SUMMARY OF PROCEEDINGS OF THE 7th SESSION OF NWFP ASSEMBLY MONDAY 2nd MARCH, 2009.

The seventh session was summoned by Governor NWFP under clause (a) of Article 109 of the Constitution of the Islamic Republic of Pakistan.

- Mr. Kiramatullah Khan, Speaker assumed the chair at 11:40 A.M. and proceedings commenced with recitation from the Holy Qur'an.
- Mr. Imtiaz Khan Shahgai, MPA took Oath as Member of Provincial Assembly of NWFP elect during bye election held on 23rd February, 2009 and signed the Role of Members.

Note:-

- In view of accidental death of Iftikhar Khan Shahgai, Ex-MPA his seat became vacant and consequently bye election was held in PF-30 Mardan. As a result of bye election, his elder brother, Mr. Imtiaz Khan Shahgai, returned to the Provincial Assembly.

- Engineer Javed Iqbal Tarakai, MPA raised an issue that his supporters were being harassed/victimized by the police ASI Swabi. In his statement, he said that such an issue was raised by him in the previous session as well but no action was taken by the Government. He than staged walkout. Later on, he ended the walkout when persuaded by the senior legislatures. Mr. Speaker constituted a Special Committee consisting of Law Minister, Mr. Abdul Akbar Khan, MPA and Syed Murid Kazim Shah, MPA to probe into the alleged political victimization and submit report within 10 days.
- 8. On a motion moved by Mr. Saqibullah Khan Chamkani, MPA rules were suspended and the House unanimously passed a resolution paying rich tribute to Alam Zeb Khan, who passed away in a fatal bomb blast. In the resolution the efforts and endeavor of the deceased was very much appreciated.
- 9. In the wake of Supreme Court Judgment disqualifying the Sharif brothers and imposition of Governor's rules in the Province of Punjab, discussion took place and the following members took part in the discussion:-
