In a joint resolution passed unanimously the House recommended the Federal Government especially to the President and Prime Minister of Pakistan to decorate assassinated MPA Alam Zeb Khan (Late) with either Nishan Pakistan, Nishan Shujaat or Nishan Imtiaz for his sacrifice for the restoration of peace.

5. In another joint resolution passed unanimously the House recommended gallantry Award Hilal-e-Shaujaat for Afzal Khan Lala who stood like iron wall against militancy in restive Swat Valley.

6. In a third joint resolution passed unanimously the House recommended the renaming of Tehsil Headquarter Hospital Puran District Shangla as Pir Muhammad Hospital Puran.

7. In a fourth joint resolution passed unanimously the House strongly condemned terrorist attack on Sri Lankan Cricket Team Lahore, prayed for the departed souls and asked the Punjab Government to investigate the matter and award punishment to the culprits.
