

SUMMARY OF PROCEEDINGS OF 9th OCTOBER 2009

The House commenced with recitation from the Holy Quran followed by Urdu translation at 10:40 A.M. Mr. Kiramatullah Khan, Speaker, Provincial Assembly was in the Chair.
