LEGISLATIVE BUSINESS

3. (a) Upon the motion of Barrister Arshad Abdullah, Minister for Law, Parliamentary Affairs & Human Rights, the House considered the Khyber Pakhtunkhwa Provincial Ombudsman Bill, 2010 clause by clause and adopted amendments in the following clauses:-

- (i) clause 3(2)
- (ii) clause 6(4)
- (iii) clause 7
- (iv) clause 14(9)

(b) The House passed the Khyber Pakhtunkhwa Provincial Ombudsman Bill, 2010 upon the motion of Barrister Arshad Abdullah, Minister for Law, Parliamentary Affairs & Human Rights with amendments.

SUSPENSION OF RULE-124 UNDER RULE-240.

4. The House suspended rule-124 of the Provincial Assembly of N.W.F.P, Procedure and Conduct of Business Rules, 1988 upon the motion of Mufti Kifayatullah, MPA and passed unanimously a joint Resolution of the following Hon'ble Members condemning the Drone attacks and recent intrusion of Nato Forces in the territory of Pakistan which they termed it an attack on the

sovereignty of Pakistan and demanded from the Federal Government to agitate against the American and its allied countries and take solid steps to halt such attacks in future.
