LEGISLATIVE BUSINESS

 (Amendment) Bill, 2011 for consideration upon the motion of Mr.

 Muhammad Zamin Khan Advocate, MPA/ Member-In-Charge and was kept pending as the Minister for Law, Parliamentary Affairs and Human Rights did not support clause 2 (b) of the Bill.
- Mr. Ameer Haider Khan Hoti, Chief Minister, Khyber Pakhtunkhwa informed the House that Government was taking measures to control illegal supply of Cattle to Afghanistan. In this regard the Federal Government had asked to minimize export quota of Cattle for Afghanistan as well as to reduce number of permits for the transportation of Cattle heads to tribal area, which would help control prices of muton and beef in the Province. He further would help control prices of muton and beef in the Province Bannu informed regarding imposition of loading and unloading tax in district Bannu

that under the Local Government Ordinance, 2001 Tehsil Municipal Officer had been empowered to levy taxes and the same tax had also been imposed in Kohat and Lakki Marwat Districts while it would be extended to other districts of the Province, so that the District Government should generate revenues of the rown sources to fulfill their requirements.
