DISCUSSION ON ADJOURNMENT MOTION No. 263 MOVED BY MR. ABDUL AKBAR KHAN, MPA ADMITTED UNDER RULE-73.

In continuation of discussion on Adjournment Motion No.263 moved by Mr. Abdul Akbar Khan, MPA pertaining to devolution of Higher Education Commission, Qazi Muhammad Asad Khan, Minister for Higher Education in his winding up speech informed the House that the Provincial Government has decided to establish its own Provincial Higher Education Council (PHEC) having full financial and administration autonomy to look after the affairs of Public Sector Universities to follow the vision and model of Dr. Atta-ur-Rehman being founder of the HEC. He said that Vice Chancellors of the Universities Khyber Pakhtunkhwa had supported establishment of the Council and the Province have the capacity and financial resources to run the Council. The Government would not compromise on quality of education and research and would improved its standard. He further said that the Provincial Government had released Rs. 246 million for PhD scholarships during the current financial year non over a wrong perception has been created that research programme would be terminated after the HEC devolution. He supported the devolution of HEC.
