SUMMARY OF PROCEEDINGS OF THE 18th SESSION

Friday 29th April, 2011

The proceedings of the House commenced with recitation from the Holy Quran followed by its Urdu translation at 10:55 A.M. Mr. Khushdil Khan Advocate, Deputy Speaker, Provincial Assembly was in the Chair.

WANT OF QUORUM

2. Want of quorum was pointed out by Mr. Mohammad Javid Abbasi, MPA, the Chair directed to count the members, but the quorum was complete and thereafter the proceedings commenced with questions hour.

LEGISLATIVE BUSINESS

8. (a) Mr. Liaqat Ali Shabab, Minister for Excise & Taxation introduced the Khyber Pakhtunkhwa Urban Immovable Property Tax (Amendment) Bill, 2011 in the House.
- (b) Barrister Arshad Abdullah, Minister for Parliamentary Affairs & Human Rights introduced the Khyber Pakhtunkhwa Removal from Service (Special Powers) (Repeal) Bill, 2011 in the House on behalf of Chief Minister.
- (c) Upon the motion of Barrister Arshad Abdullah, Minister for Law, Parliamentary Affairs and Human Rights on behalf of Chief Minister the House considered the Khyber Pakhtunkhwa Public Service Commission Bill, 2011 clause by clause and passed with out amendments.
9. During the course of consideration stage of the Khyber Pakhtunkhwa Public Service Commission Bill , 2011 Malik Qasim Khan Khattak, MPA pointed out want of quorum, the Chair directed to sound the Bills for two minutes, thereafter the quorum was formed and the proceedings commenced.
