

## SUMMARY OF PROCEEDINGS

MONDAY 26<sup>TH</sup> SEPTEMBER 2011

20<sup>TH</sup> SESSION

#### 5. THE KHYBER PAKHTUNKHWA CHILD PROTECTION AND WELFARE (AMENDMENT) BILL, 2011.

Mst. Noor Sahar, MPA moved for leave to introduce the Khyber Pakhtunkhwa Child Protection And Welfare (Amendment) Bill, 2011. It was opposed by the Minister for Social Welfare & Women Empowerment, consequently, on the request of Barrister Arshad Abdullah, Minister for Law, Parliamentary Affairs and Human Rights the mover withdrew her Bill.

#### 6. THE PROVINCIAL ASSEMBLY OF KHYBER PAKHTUNKHWA SPEAKER & DEPUTY SPEAKER'S (SALARIES, ALLOWANCES AND PRIVILEGES) (AMENDMENT) BILL, 2011.

The House granted leave for introduction of the above Bill upon the motion of Mr. Khushdil Khan Advocate, Deputy Speaker and the Bill was introduced by him in the House.

#### 7. THE KHYBER PAKHTUNKHWA PROVINCIAL EMPLOYEES GROUP INSURANCE BILL, 2011.

Mr. Abdul Akbar Khan, MPA moved for leave to introduce the Khyber Pakhtunkhwa Provincial Employees Group Insurance Bill, 2011 but on the request of Senior Minister for LGE&RD the Bill was kept pending. The Senior Minister also assured him that a comprehensive Government Bill on the subject would be brought within forty-five days.

- Resolution No. 616 was moved Mr. Saqib Ullah Khan Chamkani, MPA and not pressed by him but the Chair directed the concerned Department to hold a meeting with the mover for resolution of matter raised in the motion.
