4. **THE NATIONAL DISASTER MANAGEMENT (KHYBER PAKHTUNKHWA) (AMENDMENT) BILL, 2012.**

The National Disaster Management (Khyber Pakhtunkhwa) (Amendment) Bill, 2012 was introduced upon the motion of Barrister Arshad Abdullah, Minister for Law, Parliamentary Affairs and Human Rights on behalf of Chief Minister in the House.

5. **THE KHYBER PAKHTUNKHWA PUBLICATION OF THE HOLY QURAN (ELIMINATION OF PRINTING AND RECORDING ERRORS) BILL, 2012.**

The Khyber Pakhtunkhwa Publication of the Holy Quran (Elimination of printing and Recording Errors) Bill, 2012 was considered clause by clause and passed by the House upon the motion of Mr. Namroz Khan, Minister for Auqaf, Hajj, Religious and Minority Affairs.

10. SUSPENSION OF RULE-124 UNDER RULE-240.

Upon the motion of Mr. Bashir Ahmad Bilour, Senior Minister for Local Government, Elections and Rural Development, the House suspended rule-124 under rule-240 and passed unanimously a joint resolution moved by Mr. Abdul Akbar Khan, MPA, Mr. Muhammad Javaid Abbasi, MPA, Mufti Kifayatullha, MPA, Hafiz Akhtar Ali, MPA, Mr. Akram Khan Durrani, Leader of Opposition, Haji Qalandar Khan Lodhi, MPA, Mr. Sikandar Hyat Khan Sherpao, MPA and Mr. Abdul Sattar Khan, MPA condemning the resolution table by the Republican Congressman in the House of Representatives with regard to self determination for the people of Balochistan.
