- Mr. Muhammad Zamin Khan, MPA while referring Article 124 of the Constitution of Islamic Republic of Pakistan agitated that the Provincial Government expends excess of authorized expenditures but it does not get the approval of the excess budget from the Assembly which is gross violation of the Article *ibid*. The Chair seconded his point and decided it valid.

The general discussion on the Budget was concluded by the speech of Mr. Muhammad Hamayun Khan, Minister for Finance.
