**7. THE KHYBER PAKHTUNKHWA ENVIRONMENTAL PROTECTION BILL, 2014.**

- (e) in after clause 7, insertion of a new clause 7A; and
- (f) in clause 12, in sub-clause (1), after paragraph(viii), insertion of new paragraphs (ix) and (x).

**8. THE KHYBER PAKHTUNKHWA INJURED PERSONS AND EMERGENCY (MEDICAL AID) BILL, 2014.**

Upon the motions of Mr. Shah Ram, Senior Minister for Health, the House considered "the Khyber Pakhtunkhwa Injured Persons and Emergency (Medical Aid) Bill, 2014" clause by clause and passed it.
