3. CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA LOCAL GOVERNMENT (AMENDMENT) BILL, 2017. Upon the motions of Mr. Inayatullah, Senior Minister for Local Government the above captioned Bill was considered clause by clause and passed by the House with Amendments.

4. CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA FOOD SAFETY AUTHORITY (AMENDMENT) BILL, 2017. Upon the motions of Mr. Inayatullah, Senior Minister for Local Government the above captioned Bill was considered clause by clause and passed by the House.

5. TIME EXTENTION, PRESENTATION AND ADOPTION OF THE REPORT OF STANDING COMMITTEE NO. 8 ON HIGHER EDUCATION, ARCHIVE & LIBRARIES DEPARTMENT. Time period for presentation of the said report was extended by the House upon the motion of Mr. Sardar Farid Khan, MPA/Member of the Committee and thereafter the report was presented and adopted by the House.

6. CALL ATTENTION NOTICES. The following Call Attention Notices were taken up,-
  - i. No. 1161 of Mr. Sardar Aurangzeb Nalotha, MPA was taken up and Mr. Atif Khan, Minister for Elementary and Secondary Education made statement on it.
  - ii. No. 1179 of Ms. Rashida Riffat, MPA was taken up and Mr. Mushtaq Ahmad Ghani, advisor to C.M for Higher Education made statement on it.
  
7. QUESTION HOUR. The following questions relating to the Higher Education, Archive & Libraries, Elementary & Secondary Education and Information, Public Relation& Culture Departments were taken up for answer,-

9. SUSPENSION OF RULE-124 UNDER RULE-240. In suspension of Rule 124 under rule240 the following resolutions were unanimously adopted by the House:-
  - i. Resolution of Mr. Fakher Azam Wazir, MPA relating to ensuring of Pakistan International Airlines flights in their schedule timing and reduction of losses to PIA without shifting the financial burden to Passengers.
  - ii. Resolution of Mr. Fakher Azam Wazir, MPA regarding starting of daily PIA flights from Peshawar to Lahore.
