

**SUMMARY OF PROCEEDINGS WEDNESDAY,
THE 21st FEBRUARY, 2018**

Proceedings of the House commenced with recitation from the Holy Quran followed by its Urdu translation at 3:38 P.M. Ms. Meher Taj Roughani, Deputy Speaker, Provincial Assembly was in the Chair.

2. QUESTION HOUR. The following questions relating to the Higher Education, Archives & Libraries and Elementary & Secondary Education Departments were taken up for answers,-

4. INTRODUCTION, CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA CENSORSHIP OF MOTION PICTURES (FILMS, CDs, VIDEOS, STAGE DRAMAS AND SHOWS) BILL, 2018. 6. CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA MARRIAGE FUNCTIONS (PROHIBITION OF OSTENTATIOUS DISPLAYS AND WASTEFUL EXPENSES BILL, 2018. Upon the motions of Ms. Rashida Riffat, MPA/Member-in-Charge, the House considered the above captioned Bill clause by clause as reported by the Select Committee and passed by the House.

7. CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA LOCAL GOVERNMENT (AMENDMENT) BILL, 2018. Upon the motions of Mr. Inayatullah, Senior Minister for Local Government, the above captioned Bill was considered clause by clause and passed by the House.
