6. CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA UNIVERSITIES (AMENDMENT) BILL, 2018. Upon the motions of Mr. Shah Ram Khan, Senior Minister for Health on behalf of Minister for Higher Education the above captioned Bill was considered clause by clause and passed by the House.

7. CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA EMPLOYEES (REGULARIZATION OF SERVICES) BILL, 2018.

Upon the motions of Mr. Mahmood Khan, Minister for Sports, Tourism, Culture, Archaeology, Museum and Youth Affairs on behalf of Chief Minister the above captioned Bill was considered clause by clause and passed by the House with amendment in Schedule.

ii. Joint resolution moved by Mr. Saleem Khan, MPA demanding the Federal Government not to reduce the number of Provincial Assembly seats in Abbottabad, Chitral, Haripur, Charsadda and Swabi Districts.
