CONSIDERATION & PASSAGE OF THE KHYBER PAKHTUNKHWA CENTRE OF EXCELLENCE ON COUNTERING VIOLENT EXTREMISIM BILL, 2021.** Upon the motions of Mr. Kamran Khan Bangash, Special Assistant to CM for Higher Education, the above-captioned Bill was considered clause by clause by the House and passed with the amendment in sub-clause (2) of clause 4 as moved by Ms. Nighat Yasmin Orakzai, MPA.
