

WEDNESDAY, THE 15th AUGUST, 2018

Proceedings of the House commenced with recitation from the Holy Quran followed by its Urdu translation at 10:53 A.M. Mr. Sardar Aurangzeb Nalotha, Presiding Officer was in the Chair.

2. The Presiding Officer took Oath from Ms. Nadia Sher Member-elect and thereafter she signed Roll of Members.

3. **Election of Speaker.**-The Secretary Assembly read out the names of candidates i.e. Mr. Mushtaq Ahmad Ghani, MPA proposed by Arbab Jehandad and Kamran Bangash, MsPA, and Mr. Laiq Muhammad Khan, MPA proposed by Faisal Zeb Khan, MPA for election of Speaker. The Assembly thereafter proceeded to elect the Speaker by secret ballot in the manner specified by the Presiding Officer. Total 108 members were present who casted their votes in which Mr. Mushtaq Ahmad Ghani, MPA secured 81 votes whereas Mr. Laiq Muhammad Khan, MPA secured 27 votes.

4. **Oath to the Office of Speaker.**- Mr. Mushtaq Ahmad Ghani, MPA being declared elected as Speaker by the Presiding Officer, took oath of office before the Provincial Assembly in the form as set out in the Third Schedule of the Constitution of Islamic Republic of Pakistan. Thereafter, Mr. Mushtaq Ahmad Ghani, Speaker Provincial Assembly of Khyber Pakhtunkhwa took the Chair.

5. **Election of Deputy Speaker.**- The Secretary Assembly read out the names of candidates i.e. Mr. Mehmood Jan, MPA proposed by Taj Muhammad Khan and Mr. Asif Khan, MsPA, and Mr. Jamshaid Khan, MPA

proposed by Mian Zia-ur-Rehman, MPA for election of Deputy Speaker. The Assembly thereafter proceeded to elect the Deputy Speaker by secret ballot. Total 109 members were present who casted their votes in which Mr. Mehmood Jan, MPA secured 78 votes and Mr. Jamshaid Khan, MPA secured 30 votes whereas one vote was rejected.

6. Oath to the Office of Deputy Speaker.- Mr. Mehmood Jan, MPA being declared elected as Deputy Speaker by the Speaker, took oath of office before the Provincial Assembly in the form as set out in the Third Schedule of the Constitution of Islamic Republic of Pakistan.

7. Announcement of date and time of election of the Chief Minister.-The Chair announced that nomination papers for election of the Chief Minister can be submitted till 3:00P.M and scrutiny will be held at 4:00P.M of today i.e. 15th August 2018 whereas election of the Chief Minister will be held on 16th August, 2018 at 11.00a.m in accordance with the procedure prescribed in the Fifth Schedule read with rule 18B of the Provincial Assembly of Khyber Pakhtunkhwa Procedure and Conduct of Business Rules, 1988.
