

## SUMMARY OF PROCEEDINGS WEDNESDAY

### THE 20TH MARCH, 2019

Proceedings of the House commenced with recitation from the Holy Quran followed by its Urdu translation at 02:40 P.M. **6. INTRODUCTION OF THE KHYBER PAKHTUNKHWA PROMOTION, PROTECTION AND ENFORCEMENT OF HUMAN RIGHTS (AMENDMENT) BILL, 2019.** Mr. Sultan Muhammad Khan, Minister for Law introduced the above captioned Bill in the House.

**7. MOTION FOR LEAVE AND INTRODUCTION OF THE KHYBER PAKHTUNKHWA PROVINCIAL BUILDINGS (MANAGEMENT, CONTROL AND ALLOTMENT) (AMENDMENT) BILL, 2019.** The House granted leave for introduction of the above-captioned Bill upon the motion of Mr. Muhammad Arif, MPA and it was introduced by him.

**8. CONSIDERATION AND PASSAGE OF THE PAK-AUSTRIA FACHHOCHSCHULE INSTITUTE OF APPLIED SCIENCES & TECHNOLOGY, HARIPUR BILL, 2019.** Upon the motions of the Mr. Sultan Muhammad Khan, Minister for Law the House considered the above captioned Bill clause by clause as an additional agenda item and passed it with the amendments as proposed by Mr. Salahud Din, MPA in clauses 24 and 30.

**9. ADOPTATION OF RESOLUTION IN SUSPENSION OF RULE.** In suspension of Rule 124 under rule 240 a joint resolution moved by Ms. Rehana Ismail, MPA, regarding condemnation of objectionable portraits and inappropriate slogans in women's day rallies held in big cities on 8th March, 2019 and recommending to the Federal Government to expose hidden forces behind such rallies, was unanimously adopted by the House.

**10. BUSINESS OUTSTANDING AT THE TERMINATION OF THE SITTING.-** At the termination of the sitting the following business remained outstanding,-
