

SUMMARY OF PROCEEDINGS OF MONDAY, THE 1ST AUGUST, 2022

Proceedings of the House commenced with recitation from the Holy Quran followed by its Urdu translation at 02:52 P.M. Mr. Muhammad Idrees Khan, Chairman from the Panel of Chairmen presided over the sitting.

2. Upon the motion of Ms. Nighat Yasmin Orakzai, MPA, the House changed the order of business fixed for the day and transacted it in the following order.

3. **INTRODUCTION OF THE KHYBER PAKHTUNKHWA FINANCE (AMENDMENT) BILL, 2022.** Mr. Taimoor Saleem Khan Jhagra, Minister for Finance introduced the above captioned Bill in the House.

4. **CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA LISSAAIL-E-WAL MAHROOM FOUNDATION (AMENDMENT) BILL, 2022.** The House resumed consideration of the above-captioned Bill and it was considered clause by clause and passed by the House upon the motion of Mr. Fazal Shakoor Khan, Minister for Law.

5. **CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA COMMERCE AND TRADE STATISTICS BILL, 2022.** Upon the motions of Mr. Fazal Shakoor Khan, Minister for Law, the above captioned Bill was considered clause by clause and passed by the House.

6. **CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA MEDICAL OFFICERS OF HEALTH DEPARTMENT (REGULARIZATION OF SERVICES) BILL, 2022.** Upon the motions of Mr. Taimoor Saleem Khan Jhagra, Minister for Health, the above captioned Bill was considered clause by clause and passed by the House with verbal amendments of Minister for Health in clauses 3 and 5.

7. **TIME EXTENSION, PRESENTATION AND ADOPTION OF REPORTS OF PUBLIC ACCOUNTS COMMITTEE ON THE ACCOUNTS OF KHYBER PAKHTUNKHWA FOR THE YEAR 2016-17 AND 2017-18.** Upon the motion of Mr. Arbab Waseem Hayat, MPA/Member of the Public Accounts Committee, the House granted time extension for presentation of the above-captioned Reports in the House. The Reports were presented by him and upon his motion the said Reports were adopted.
