7. INTRODUCTION OF THE KHYBER PAKHTUNKHWA REGULARIZATION OF SERVICES OF EMPLOYEES OF DISTRICT GOVERNANCE AND COMMUNITY DEVELOPMENT PROJECT BILL, 2022. Mr. Kamran Khan Bangash, Minister for Higher Education, introduced the above captioned Bill in the House.

8. CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA FISHERIES AND AQUACULTURE BILL, 2022. Upon the motion of Mr. Kamran Khan Bangash, Minister for Higher Education, the above captioned Bill was considered clause by clause and passed by the House.

9. CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA TEACHERS (APPOINTMENT AND REGULARIZATION OF SERVICES) BILL, 2022. As an additional agenda item, the above captioned Bill was considered clause by clause and passed by the House with the following amendments:-

- i. in clause 2, in sub-clause (1), in paragraph (d), after the word “ad-hoc”, the slash and word “/contract” was inserted as proposed by Syed Fakhar Jehan, MPA.
- ii. in clause 2, in sub-clause (1), in paragraph (d), after the words “National Testing Service”, the slash , word, brackets and abbreviation“/Khyber Paktunkhwa Educational Testing and Evaluation Agency (ETEA) or any other Testing Service” were inserted as proposed by Syed Fakhar Jehan, MPA and further amended upon the verbal amendment of Mr. Shehram Khan Tarakai, Minister for Elementary & Secondary Education.
- iii. in clause 3, in sub-clause (1), for the words “with immediate effect”, the words “from the date of their initial appointment” was substituted as proposed by Syed Fakhar Jehan, MPA.
- iv. in clause 3, in sub-clause (1), in paragraph (d), after the word “ad-hoc”, the slash and word “/contract” was inserted as proposed by Syed Fakhar Jehan, MPA.
- v. in clause 3, sub-clause (3) was deleted as proposed by Syed Fakhar Jehan, MPA.
- vi. in the long title and preamble, after the word “ad-hoc”, the slash and word “/contract” was inserted as proposed by Syed Fakhar Jehan, MPA.
