**6. MOTION FOR LEAVE, INTRODUCTION, CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA EMPLOYEES OF TRANSPORT DEPARTMENT (REGULARIZATION OF SERVICES) (AMENDMENT) BILL, 2022.** Ms. Nighat Yasmeen Orakzai, MPA/Member-in-charge moved a motion under rule 240 for suspension of rule 22(1) of the Provincial Assembly of Khyber Pakhtunkhwa Procedure and Conduct of Business Rules, 1988 to the extent of taking-up the above-captioned private member's Bill as an additional agenda item for transaction under rules 77, 82 and 105 which was adopted by the House.

Leave was granted by the House upon the motion of the Member-in-charge under rule 77 and the said Bill was introduced. After introduction, the Bill was taken into consideration at once upon a motion under rule 82 moved by the Member-in-charge and it was passed by the House upon her motion under rule 105.

**7. CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA MINISTERS (SALARIES, ALLOWANCES AND PRIVILEGES) (AMENDMENT) BILL, 2022.** Upon the motions of Mr. Shaukat Yousafzai, Minister for Parliamentary Affairs, the above captioned Bill was considered clause by clause and passed by the House.

**8. CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA REGULARIZATION OF SERVICES OF EMPLOYEES OF DISTRICT GOVERNANCE AND COMMUNITY DEVELOPMENT PROJECT BILL, 2022.** Upon the motions of Mr. Faisal Amin Gandapur, Minister for Local Government, the above captioned Bill was considered clause by clause and passed by the House.

**9. RESOLUTION.** In suspension of Rule 124 under rule 240 a joint Resolution regarding price hike was moved by Mr. Shaukat Yousafzai, Minister for Parliamentary Affairs but it was not put to vote due to lack of quorum.
