ORDER:

The Commissioner / Chairman Regional Transport Authority Peshawar has been pleased to grant a parking place permission to Mr. Abbas khan S/O Hasham Khan R/O Mohalla Aziz khel Mattani Peshawar for the operation of Suzuki Pickup / Datsun service on the mattani to Bara from a site located at Frontier Road Mattani.

This order is made under Rule-248 of the Motor Vehicle Rules 1969, read with Section-80 of the Motor Vehicle ordinance 1965 and will remain in force for period of one year up to 14-07-2021 with the following conditions:

- 7. The said parking place permission is issued after obtaining of NOC's from Municipal Administration/District Administration and traffic Authorities.
- 8 The vehicles operated from site will be in possession of valid up to date route permit/fitness certificate and registration.
