

The Chairperson informed the committee that short listing were been made among the registered candidates of employment exchange and the short listed candidates were informed through posts doc letter/mail. Furthermore the Chairman elaborated that some candidates approached the office of the Principal who has valid employment registration card but their names were not included in the list so the committee decided that all the candidates will be allowed for interview that have a valid employment exchange registration card of District Peshawar. 4. Skill if Any. Total Marks-20)

The committee discussed that the Routine functioning of the college requires services of technical persons like electrician, plumber, Driver, mason, automobile mechanic, automobile electrician, tailor, wilder, carpenter, painter, computer skills etc, to do the petty jobs but due to non-availability from within the college staff external services are hired on heavy payments. Beside this the need of various technical persons hired from local market arouse multiple complications for the students as well as administration. hence, it was decided that skilled persons in the above mentioned fields shall be given more preference. Those candidates will be preferred who are having extra or additional skills to facilitate this hugely populated college which has a huge number of female students. Total 10 marks will be allocated to additional skills. 05 marks will be allocate to a candidate having one year of experience in additional skills like electrician, plumber, Driver, mason, automobile mechanic, automobile electrician, and tailor, wilder, carpenter, painter, computer skills etc and 05 marks will be awarded per annum up to total 10 marks. Onward will be consider as additional quality. in case of tie in between the two candidate a candidate having more experience in skills will be preferred.

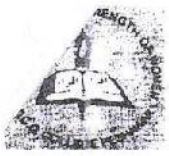
5. Interview Marks. (Total Marks-30)

The recommendation of the candidate will be made by converting the below mentioned criteria which was formed after threadbare discussion in the meeting in numeric form. Total 100 marks will be allocated in which a candidate with achieving high marks will be recommended.

1. Distance from the college concerned (Total Marks- 30)

The committee discussed the Para-Meter of Distance and its importance in the delivery of good services from among the low paid salary staff in detail in the light of Establishment rules-12 sub rule-3 which clearly mentioned the word "local" for the post of BPS-1 and 2 of that time which was replaced by to BPS-03 and BPS-05, vide Notification SO(R-VI)E&AD/1-3/2015 dated April 19,2016. The committee decided that word local will be extended up to 5 KM. the candidate belonging from a place which has more distance than five km will be eliminated from the Selection to implement the local based policy in the appointment of Class-IV. The committee decided that those candidates will be awarded high marks who are nearer to the college and full filling the required Codal formalities and by attaining meritorious position. For locality total 30 marks will be allocated. One km circumference will awarded 30 marks, 3 km circumference 20 marks will be awarded, and for 5 km circumference 10 marks will be awarded. The committee further decided that candidate having more distance than five KM will not be assessed due to the eliminating criteria already decided.

2. Academic Qualification. (Total marks-10)

It was decided that candidates having SSC qualification or above will be given equal weight as higher qualification is of little importance for such posts. Further, the candidates with higher qualification do not opt for such posts as their permanent profession rather they occupy the posts momentarily and remain in constant struggle for higher grades. Hence, posts are vacated time and again. It was also pointed out that nature of the job in the above mentioned posts is more of physical than mental nature of which higher qualified employees often remain shy and reluctant to perform the duties of class-IV. The committee decided that 10 marks will be allocated to qualification: its further clarification is Primary 5 marks, middle 08 marks, and Metric 10 marks. Qualification more than this will be consider as preference in case on tie amongst the total aggregate of candidates

3. Physical Appearance (Total Marks-10)

The principal informed the committee that this college was full of problems. In his tenure the things we're been channelized to meet out the college need physically fit and agile candidate will be preferred. Keeping in view the points of the principal/chairperson of the committee decided that behavior and look up the candidate will be checked accordingly. Total 10 marks have been reserved for the behavior and look up. The committee will allocate the marks to each candidate by their mutual consensus.

- i. The criteria will be in numeric form of 100 marks with the following parameters and weightage.
- ii. Each Candidate will be assessed during the interview with questions answers and complete checking of documents, NIC, Domicile, Employment Exchange Registration as well as Demo if required.
- iii. Marks will be awarded to each candidate through mutual consensus of Departmental Selection Committee after the completion of interview of each candidate.
- iv. The merit position of all the candidates will be assessed who are within the criterion.
- v. Candidates who's homes are at a distance of more than 10 km will be eliminated from assessment.
- vi. All the candidates will be credit the marks one time and no duplication in marks will be made to any candidate. The same will help the committee to find the deserving candidate and will avoid to provide extra edge to any candidate.

2. Qualification. (Total 10 marks)

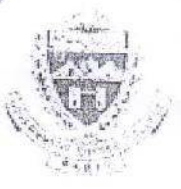

Metric 10 marks. Qualification more than this will be consider as preference in case on tie amongst the total aggregate of candidates.

5. Relevant Experience (Total Marks-10)

Experience in educational institutions will be consider as relevant experience total 10 marks will be awarded in the column of experience. Per annum 5 marks will be awarded up to maximum 10 marks. Onward will be consider as additional quality, in case of tie in between the two candidate a candidate having more experience will be preferred. Hence, it was decided that skilled persons in the above fields shall be given more preference. Those candidates will be preferred who are having extra or additional skills to facilitate this college situated out of the mega city. Total 10 marks will be allocated to additional skills. 10 marks will be allocate to a candidate having one year of experience in additional skills like electrician, plumber, Driver, mason, automobile mechanic, automobile electrician, and tailor, wilder, carpenter, painter, computer skillsetc and 05 marks will be awarded per annum up to total 10 marks.
