In clause 13, in sub-clause (n), in sub-section (3) of the proposed section 92A, after the existing paragraph (d), semicolon and the word ";and" was deleted and the existing paragraphs (e), (f)

and (g), corrected as (o), (p) and (q), respectively, as patent errors.
