I am directed to say that the Provincial Assembly of Khyber Pakhtunkhwa in its sitting held on 25-04-2017 has passed the Resolution No. 952 moved by Dr. Haider Ali, Parliamentary Secretary, as also sign by Mr. Sikandar Hayat Khan Sherpao, Senior Minister for Irrigation, Mr. Inayatullah, Senior Minister for Local Government, Syed Muhammad Ali Shah, Member Provincial Assembly of Khyber Pakhtunkhwa as follows.

**Resolution**

“In view of the Judgment passed by the Hon’able Judges of the Supreme Court of Pakistan on 20<sup>th</sup> April, 2017 in Panama case regarding the Prime Minister of Pakistan Mian Nawaz Sharif and his Family, non of the Judges gave clean chit to the Prime Minister and his family. Two of the senior most Judges declared the Prime Minister as disqualified from the Prime Minister ship, on their remarks all the judges are of the view that Prime Minister could not prove & justify his assets to be acquired by legal means and asked for further enquiry.

Therefore, this house believes that the Prime Minister has lost his moral authority and demands his resignation immediately till the final decision.”

I am further directed to say that under Sub-rule (3) of rule 135 of the Provincial Assembly of Khyber Pakhtunkhwa Procedure and Conduct of Business Rules, 1988 the Department concerned of the Government shall report to the Assembly Secretariat about the action taken on the resolution within a period of two months from the date of its communication.
