**THE KHYBER PAKHTUNKHWA ESTABLISHMENT OF DISTRICT DEVELOPMENT
ADVISORY COMMITTEES (AMENDMENT) ACT, 2010.

*further to amend the North-West Frontier Province Establishment of
District Development Advisory Committees Act, 1989.*

Preamble. WHEREAS it is expedient to amend the North-West Frontier Province Establishment of District Development Advisory Committees Act, 1989 (N.W.F.P. Act No. IV of 1989), for the purposes hereinafter appearing;

It is hereby enacted as follows:-

1. **Short title and commencement.**— (1) This Act may be called the Khyber Pakhtunkhwa Establishment of District Development Advisory Committees (Amendment) Act, 2010.

(2) It shall come into force at once.

2. **Amendment in section 2 of NWFP Act No. IV of 1989.**— In the North-West Frontier Province Establishment of District Development Advisory Committees Act, 1989 (N.W.F.P. Act No. IV of 1989), in section 2, para (g) may be substituted by the following, namely;—

"(g) "Project Director" means any Officer to be appointed by the Government;"

3. **Substitution of section 5 of NWFP Act No. IV of 1989.**— In the North-West Frontier Province Establishment of District Development Advisory Committees Act, 1989 (N.W.F.P. Act No. IV of 1989), section 5 shall be substituted by the following namely;—

"5. **Administrative approval and implementation of schemes.**— All other schemes included in the Annual Development Programme, which are subject to the advice of the Committee, shall be administratively approved and implemented by the Government Departments concerned in accordance with the prescribed procedure of the Department or as may be directed by Government:

Provided that the District Local Fund shall not be included in the purview of District Development Advisory Committee."

4. **Amendment in section 9 of NWFP Act No. IV of 1989.**— In the North-West Frontier Province Establishment of District Development Advisory Committees Act, 1989 (N.W.F.P. Act No. IV of 1989), in section 9 and wherever the words "Assistant Director, Local Government" are occurring in the said Act the words "or any other Officer to be appointed by the Government" shall be added.
