No. PA/Khyber Pakhtunkhwa/Bills/2016/4979.—The Khyber Pakhtunkhwa Local Government (Amendment) Bill, 2016 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 10<sup>th</sup> August, 2016 and assented to by the Governor of the Khyber Pakhtunkhwa on 15<sup>th</sup> August, 2016 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

*further to amend the Khyber Pakhtunkhwa  
Local Government Act, 2013*

WHEREAS it is expedient further to amend the Khyber Pakhtunkhwa Local Government Act, 2013 (Khyber Pakhtunkhwa Act No. XXVIII of 2013), for the purpose hereinafter appearing;

It is hereby enacted as follows:-

1. **Short title and commencement.**— (1) This Act may be called the Khyber Pakhtunkhwa Local Government (Amendment) Act, 2016.

(2) It shall come into force at once.

2. **Amendment of section 79 of the Khyber Pakhtunkhwa Act No. XXVIII of 20143**— In the Khyber Pakhtunkhwa Local Government Act, 2013 (Khyber Pakhtunkhwa Act No. XXVIII of 2013), hereinafter referred to as the said Act, in section 79, in sub-section (2), the colon at the end shall be replaced by full stop and thereafter the existing provisos thereunder shall be deleted.
3. **Amendment in section 84 of the Khyber Pakhtunkhwa Act No. XXVIII of 2013.**— In the said Act, in section 84, in sub-section (2), for the words “approve the budget”, the words “approve the first budget” shall be substituted.
4. **Repeal.**— The Khyber Pakhtunkhwa Local Government (Amendment) Ordinance, 2016 (Khyber Pakhtunkhwa Ordinance No. VIII of 2016) is hereby repealed.
