No. PA/Khyber Pakhtunkhwa/Bills/2017/12934.—The Khyber Pakhtunkhwa Local Government (Amendment) Bill, 2017 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 24<sup>th</sup> October, 2017 and assented to by the Governor of the Khyber Pakhtunkhwa on 1<sup>st</sup> November, 2017 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

#### THE KHYBER PAKHTUNKHWA LOCAL GOVERNMENT (AMENDMENT) ACT, 2017

(KHYBER PAKHTUNKHWA ACT NO. XXXIV OF 2017)

*(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 15<sup>th</sup> November, 2017).*

*further to amend the Khyber Pakhtunkhwa  
Local Government Act, 2013.*

**WHEREAS** it is expedient further to amend the Khyber Pakhtunkhwa Local Government Act, 2013 (Khyber Pakhtunkhwa Act No. XXVIII of 2013), for the purposes hereinafter appearing;

It is hereby enacted as follows:

- 1. Short title and commencement.**—(1) This Act may be called the Khyber Pakhtunkhwa Local Government (Amendment) Act, 2017.

(2) It shall come into force at once.

2. **Insertion of new section to the Khyber Pakhtunkhwa Act No. XXVIII of 2013.**---In the Khyber Pakhtunkhwa Local Government Act, 2013 (Khyber Pakhtunkhwa Act No. XXVIII of 2013), after section 115A, the following new section shall be inserted, namely:

**“115B. Local areas development authority.**---Notwithstanding anything contained in this Act, the local areas development authorities, established under various laws for the time being in force, from time to time, shall continue to exercise its functions within the jurisdiction as are assigned to them under the notifications issued in this behalf.”
