No. PA/Khyber Pakhtunkhwa/Bills/2016/8939.—The Khyber Pakhtunkhwa Medical Teaching Institutions Reforms (Amendment) Bill, 2016 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 29<sup>th</sup> March, 2016 and assented to by the Governor of the Khyber Pakhtunkhwa on 6<sup>th</sup> April, 2016 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

#### THE KHYBER PAKHTUNKHWA MEDICAL TEACHING INSTITUTIONS REFORMS (AMENDMENT) ACT, 2016

(KHYBER PAKHTUNKHWA ACT NO. II OF 2016)

*(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 11<sup>th</sup> April, 2016).*

*further to amend the Khyber Pakhtunkhwa  
Medical Teaching Institutions Reforms Act, 2015.*

WHEREAS it is expedient further to amend the Khyber Pakhtunkhwa Medical Teaching Institutions Reforms Act, 2015 (Khyber Pakhtunkhwa Act No. IV of 2015), for the purposes hereinafter appearing;

It is hereby enacted as follows:-

- 1. Short title and commencement.** --- (1) This Act may be called the Khyber Pakhtunkhwa Medical Teaching Institutions Reforms (Amendment) Act, 2016.

(2) It shall come into force at once.

2. **Amendment of section 7 of the Khyber Pakhtunkhwa Act No. IV of 2015.**---In the Khyber Pakhtunkhwa Medical Teaching Institutions Reforms Act, 2015 (Khyber Pakhtunkhwa Act No. IV of 2015), hereinafter referred to as the said Act, in section 7, in sub-section (1), after clause (c), the following new clause shall be inserted, namely:

“(c-i) creation, re-designation or abolition of posts; provided that while creating posts the financial implications do not exceed the approved annual budget;”.

3. **Amendment of section 19 of the Khyber Pakhtunkhwa Act No. IV of 2015.** ---In the said Act, in section 19, in sub-section (3), for clause (a), the following shall be substituted, namely:

“(a) grants from the Government as single line budget;”.

4. **Repeal.** --- The Khyber Pakhtunkhwa Medical Teaching Institutions Reforms (Amendment) Ordinance, 2016 (Khyber Pakhtunkhwa Ord: No. IV of 2016), is hereby repealed.
