No. PA/Khyber Pakhtunkhwa/Bills/2016/8951.—The Khyber Pakhtunkhwa Public Service Commission (Amendment) Bill, 2016 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 29th March, 2016 and assented to by the Governor of the Khyber Pakhtunkhwa on 6th April, 2016 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

THE KHYBER PAKHTUNKHWA PUBLIC SERVICE COMMISSION (AMENDMENT) ACT, 2016

(KHYBER PAKHTUNKHWA ACT NO. III OF 2016)

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 11th April, 2016).

*further to amend the Khyber Pakhtunkhwa
Public Service Commission Ordinance, 1978.*

WHEREAS it is expedient further to amend the Khyber Pakhtunkhwa Public Service Commission Ordinance, 1978 (Khyber Pakhtunkhwa Ord. No. XI of 1978), for the purpose hereinafter appearing;

It is hereby enacted as follows:-

- 1. Short title and commencement.**---(1) This Act may be called the Khyber Pakhtunkhwa Public Service Commission (Amendment) Act, 2016.

(2) It shall come into force at once.

2. Amendment of section 7 of the Khyber Pakhtunkhwa Ord. No. XI of 1978.---In the Khyber Pakhtunkhwa Public Service Commission Ordinance, 1978 (Khyber Pakhtunkhwa Ord No. XI of 1978), in section 7, in sub-section (2),-

(a) in clause (iii), the full-stop, appearing at the end, shall be replaced by a semi-colon and thereafter the word "and" shall be added; and

(b) after clause (iii), as so amended, the following new clause shall be added, namely:

"(iv) the posts of Junior Clerks in all Departments, Attached Departments and at District level."

3. Repeal.--- The Khyber Pakhtunkhwa Public Service Commission (Amendment) Ordinance, 2016 (Khyber Pakhtunkhwa Ord: No. I of 2016), is hereby repealed.
