ORDINANCE

*further to amend the North-West Frontier Province
Elementary Education Foundation Ordinance, 2002.*

WHEREAS it is expedient further to amend the North-West Frontier Province Elementary Education Foundation Ordinance, 2002 (Ord. No. XXX of 2002), for the purposes hereinafter appearing;

AND WHEREAS the Governor of the North-West Frontier Province is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in pursuance of the Proclamation of Emergency of the fourteenth day of October, 1999, as amended upto date, and the Provisional Constitution Order No. 1 of 1999, read with Article 4 of the Provisional Constitution (Amendment) Order No. 9 of 1999, and in exercise of all powers enabling him in that behalf, the Governor of the North-West Frontier Province is pleased to make and promulgate the following Ordinance:

1. **Short title and commencement.**— (1) This Ordinance may be called the North-West Frontier Province Elementary Education Foundation (Second Amendment) Ordinance, 2002.

(2) It shall come into force at once.

2. **Amendment of section 5 of Ord. No. XXX of 2002.**—(1) In the North-West Frontier Province Elementary Education Foundation Ordinance, 2002 (N.-W.F.P. Ord. No XXX of 2002), in section 5, in sub-section (1),—

- (i) clause (k) shall be deleted; and
- (ii) in clause (m), for the word "A", occurring in the beginning, the word "three" shall be substituted.
