*further to amend the North-West Frontier Province
Local Government Ordinance, 2001.*

Preamble.- WHEREAS it is expedient further to amend the North-West Frontier Province Local Government Ordinance, 2001 (N.-W.F.P. Ord. No. XIV of 2001), for the purpose, hereinafter appearing;

It is hereby enacted as follows:-

1. Short title and commencement.--- (1) This Act may be called the North-West Frontier Province Local Government (Second Amendment) Act, 2006.

(2) It shall come into force at once.

2. ***Amendment of section 42 of the N.-W.F.P. Ord. No. XIV of 2001.***--- In the North-West Frontier Province Local Government Ordinance, 2001 (N.-W.F.P. Ord. No. XIV of 2001), hereinafter referred to as the said Ordinance, in section 42, in sub-section (4), the words "through a secret ballot" appearing at the end shall be deleted.
3. ***Amendment of section 69 of the N.-W.F.P. Ord. No. XIV of 2001.***--- In the said Ordinance, in section 69, in sub-section (4), the words "through a secret ballot" appearing at the end shall be deleted.
4. ***Repeal.***- The North-West Frontier Province Local Government (Second Amendment) Ordinance, 2005 (N.-W.F.P. Ordinance No. VII of 2005) is hereby repealed.
