further to amend the North-West Frontier Province Removal from Service (Special Powers) Ordinance, 2000.

**Preamble.**—WHEREAS it is expedient further to amend the North-West Frontier Province Removal from Service (Special Powers) Ordinance, 2000.

It is hereby enacted as follows:

1. Short title and commencement.—(1) This Act may be called the North-West Frontier Province Removal from Service (Special Powers) (Amendment) Act, 2005.

- (2) It shall come into force at once.
- 2. Amendment of section 9 of N.-W.F.P. Ord. No. V of 2000.—In the North-West Frontier Province Removal from Service (Special Powers) Ordinance, 2000 (N.-W.F.P. Ord. No. V of 2000), in section 9,—
  - (a) in sub-section (1), in clause (b), for the word "presentation", the words "review petition" shall be substituted; and
  - (b) in sub-section (2),
    - (i) for the word "presentation", occurring for the first time, the words "review petition" shall be substituted; and
    - (ii) for the word "presentation", occurring for the second time, the words "review petition" shall be substituted.
