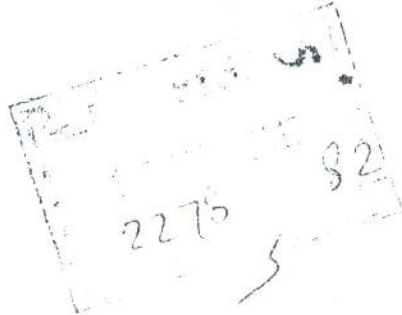

NOTIFICATION U/S-IV OF THE L.A. ACT, 1894.

Whereas, it appears to the Land Acquisition Collector Swat that land in Khasra numbers mentioned below is likely to be acquired by the Govt. at Public Expenses for a public purpose namely "Establishment/Construction of Govt. Girls Degree College Madyan District Swat".

This notification is made under the provision of Section-IV of the Land Acquisition Act 1894 to all whom it may concern.


In exercise of the powers conferred upon me by Section-IV as amended by the Land Acquisition Amendment Act, 1969 (Ordinance No.XI.IX of 1969) the Land Acquisition Collector, Swat is pleased to authorize the officers for the time being engaged in the undertaking with their servants and workmen to enter upon and survey any land in the locality and to do all other acts required or permitted by the aforesaid section.

Any person interested who has any objection to the acquisition of any land in the locality may within 30-days of the publication of this Notification, file an objection in writing before the Land Acquisition Collector Swat.



It is to bring into your notice that clearance sought in this office Memo: No. 7579/62/Acq/DC(S), dated 30/03/2016, stands still un-responded due to which the proceedings are in abeyance (copy enclosed).

Besides the above, your Department vide Memo: No. CPO(HE)/SO/2-89/GGDC Madyan/544-46 dated 10/05/2016 intended to reduce the land for the purpose to 20 Kanals preferably within Khasra Nos. 216,218,222,231,232,233 and 234 which clearly shows that per Notification U/S-4 of Land Acquisition Act 1894 Khasra No. 220 has been excluded whereas Khasra No. 231 included and about the same clarification and Justification has already been asked vide this office Memo: No. 17220/62/Acq/DC(S) dated 17/07/2017 (copies of both the letters are attached).

It is therefore requested that in light of above correspondence, the matter shall be clarified and justified enabling this office to process the case further in good manner please.

Reference your memo No. 2646 /P&D/CAP-II GGC Madyan dated 08-03-2016, on the subject noted above. P-24

It is pointed out that the mode of subject acquisition is private purchase and the cost /price of the land is being determined by District Price assessment Committee headed by the undersigned as its Chairman. The Committee is supposed also to verify the title of ownership of the land as well in such like cases. The land notified for the subject purpose is 59 Kanal 11 Marla which is including 04 residential houses with orchards in light of report of Assistant Commissioner Bahrain whereas the actual requirement of land by your department being Acquiring Department is not known for the purpose. In case, the actual requirement of land is less than the notified area, then the site selection within the notified area would be highly essential in order to take on board the concerned owners for negotiation on the rate. The position as such has already been intimated to you vide this office memo No. 19510/62/Acq/DC(S) dated 26-08-2015 (copy is attached for ready reference) but response is still awaited from your end which state of affair has kept the proceedings in abeyance. It is again requested that the position in light of the above discussion with regard to the actual requirement of land for the purpose may be clarified and in case of less requirement than the notified area, a team of Officers/ Officials of your department may be deputed for site selection within the notified area on priority basis in order to move the proceedings onward towards acquisition.
