Section 11-B(5) of the WWF Ordinance, 1971 is reproduced below:ii.

> The Provincial Government, agency or, as the case may be, body corporate may issue directions to the Board constituted by it regarding matters of policy including matters relating to scheme made under clause (a) of section 11-C;

Provided that if a difference arises as to whether a direction relates to a matter of policy, the decision of the Federal Government shall be final."

- iii. Federal Government vide Establishment Division's O. M. No.4/1/93-R.1 dated 25.9.2014 (Annex-I) have already lifted ban on recruitment process and also issued policy guidelines in this regard vide Establishment Division's O. M. No.F.53/1/2008-SP dated 22<sup>nd</sup> October, 2014 (Annex-II), which should be followed by the PWWBs in letter and spirit.
- IV. PWWBs are also advised that they should commence recruitment process against the vacant posts after securing necessary budget provision for the purpose for the financial year, 2014-15.
