

THE KHYBER PAKHTUNKHWA EHTESAB COMMISSION DIRECTOR GENERAL (TEMPORARY) (TERMS AND CONDITIONS OF SERVICE) RULES, 2016

- 1. Short title, application and commencement.---(1) These rules may be called the Khyber Pakhtunkhwa Ehtesab Commission Director General (Temporary) (Terms and Conditions of Service) Rules, 2016.
- (2) These rules shall apply to the Director General appointed on temporary basis.
 - (3) These rules shall come into force at once.
- 2. **Definition.**—In these rules unless the subject or context otherwise requires, Act means the Khyber Pakhtunkhwa Ehtesab Commission Act, 2014 (Khyber Pakhtunkhwa Act No. I of 2014).
- 3. Method of appointment of Director General on temporary basis.—
 (1) Whenever the post of Director General falls vacant due to any reason, the Chief Ehtesab Commissioner shall designate any senior officer of the Commission as Director General.
- (2) The Director General so appointed, shall exercise all the powers of the Director General appointed on regular basis for running the day to day affairs of the Commission.
