NOTIFICATION

No. SO(R-VI)E&AD/1-3/2015. In exercise of the powers conferred by Section 26 of the Khyber Pakhtunkhwa Province Civil Servants Act, 1973 (Khyber Pakhtunkhwa Act No. XXIII of 1973), the Chief Minister of Khyber Pakhtunkhwa Province is pleased to direct that in the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules 1989, the following further amendments shall be made, namely:

AMENDMENTS

1. In rule 4,-

- a) in sub-rule (3), for the figures and word "3 to 15", the figures and word "6 to 15" shall be substituted; and
- b) in sub-rule (4), for the figures and word "1 and 2", the figures and word "3 and 5" shall be substituted.

2. In rule 10,-

- a) in sub-rule (2), in second proviso, for the figures and word "1 to 4", the figures and word "3 to 5" shall be substituted; and
- b) for sub-rule (4), the following shall be substituted, namely:

(4) Where a civil servant dies or is rendered incapacitated or invalidated permanently during service or retired on medical board, notwithstanding the procedure provided for in sub-rule (2), the appointing authority may appoint one of the children of such civil servant or, if the child has not attained the age prescribed for appointment in Government service, the widow or wife as the case may be, of such civil servant, to a posts in any of the basic pay scales 3 to 11 in Provincial cadre post and basic pay scales 3 to 12 in District cadre posts:

Provided that the child or the widow or wife, as the case may be, possesses the minimum qualification prescribed for appointment to the post:

Provided further that if there are two widows or wives of the deceased civil servant, as the case may be, preference shall be given to the elder widow or wife:

Provided also that appointment under this sub-rule is subject to availability of a vacancy and if more than one vacancies, in different pay scales, are available at a time and the child or the widow or wife, as the case may be, possesses the qualifications eligible for appointment in more than one post, such child or the widow or wife, as the case may be, shall ordinarily be appointed to the post carrying higher pay scale.

Provided also that the provision of this sub-rule shall not be applicable to posts falling within the purview of the Commission.

Subject - APPOINTMENT AGAINST DECEASED EMPLOYEE'S SON QUOTA.

Dear Sir,

I am directed to refer to the subject noted above and to state that instances come to the notice of this Department timely and again regarding implementation of deceased employees son quota that different Departments do not implement the policy of deceased employees son quota on one pretext or the other. It is clarified and necessary that Honorable Peshawar High Court and Supreme Court of Pakistan have clearly stated in their judgments dated 07-01-2009 and 29-11-2012 respectively, that a government servant who dies during service, his son/daughter/widow is entitled for appointment and this is settled law of the land that a statute or rule giving right to the citizens always invariable operates retrospectively.

Hence it is clarified in light of the judgments of the Honourable Courts regarding deceased son's quota that the son/daughter/widow of a government servant who died during the service before the circulation of this policy is also entitled for appointment provided he/she fulfills the required conditions and no time limit is involved in it.

I am further directed to request that the above instructions may be brought into the notice of all concerned for information and strict compliance.

**Lifting of ban on appointment against deceased/
Rtd. Government employees children quota**

In supersession of all previous orders in this behalf, the competent authority is pleased to order lifting of ban on appointment against the following quotas;

- i) Quota reserved for deceased employees children under Rule 10 (4) of the NWFP Civil Servants (Appointment, Promotion and Transfer) Rules 1989.
- ii) Quota reserved for the children of Class-IV retired (on superannuation/invalidation) Govt. employees vide this Department's letter SOR.I(S&GAD)4-1/80 (Vol.III) dated 1.7.2000.

2. However, the above mentioned lifting of ban is subject to the following conditions:-

- i) Appointment against quota mentioned vide para No.1(i) above shall be given preference over Serial No.(ii).
- ii) For appointment against quota mentioned vide para No.1(ii) above, the following conditions must be fulfilled:
 - a) Appointments shall be made after the adjustment of employees placed in Surplus Pool.
 - b) Instructions contained in this Department letter No.SORI (S&GAD)4-1/80(Col.III) dated 23.5.2000, may be followed in letter and spirit.
