Whereas:

- The Constitution of the Islamic Republic of Pakistan guarantees a federal structure, 1. ensuring that the provinces are integral stakeholders in the governance and legislative process of the country; the Parliament Comprises of two houses and the President with equal representation from all the provinces in the Senate.
- Khyber Pakhtunkhwa (KPK), as one of the federating units, holds a vital role in the 2. country's political and constitutional framework;
- The Parliament of Pakistan, as the supreme legislative body, has the power to amend the 3. Constitution and make institutional reforms that directly impact the provinces and their citizens;
- Therefore, it is imperative that both houses of the Parliament are fully constituted and 4. truly represent the Federation of Pakistan.
- Any constitutional amendment made by the Parliament without proper representation and 5. without properly constituted Senate of Pakistan without consultation of the Khyber Pakhtunkhwa Provincial Assembly, undermines the principles of federalism and provincial autonomy.

And whereas:

- It is imperative that the voice of the KPK Assembly is heard, respected, and considered 1. when Constitutional amendments are being debated and passed in the Parliament of Pakistan;
- 2. The lack of representation of KPK in the Senate and process of amending key institutions will create a democratic deficit and legitimacy of such amendments will be in question.
- 3. The Constitution requires an inclusive approach to ensure that all provinces are fairly represented in the decision-making process.

Resolved that:

The Provincial Assembly of Khyber Pakhtunkhwa strongly urges the Parliament of Pakistan to refrain from passing any Constitutional amendments without the completion of the Senate of Pakistan and due representation and active involvement of the KPK Assembly.
