further to amend the Khyber Pakhtunkhwa Establishment of District  
Development Advisory Committee Act, 1989.

**WHEREAS** it is expedient further to amend the Khyber Pakhtunkhwa Establishment of District Development Advisory Committee Act, 1989 (Khyber Pakhtunkhwa Act No. IV of 1989). for the purposes hereinafter appearing:

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

1. **Short title and commencement.**---(1) This Act may be called the Khyber Pakhtunkhwa Establishment of District Development Advisory Committee (Amendment) Act, 2024.

(2) It shall come into force at once.

2. **Amendment of section 3 of the Khyber Pakhtunkhwa Act No. IV of 1989.**---In the Khyber Pakhtunkhwa Establishment of District Development Advisory Committee Act, 1989 (Khyber Pakhtunkhwa Act No. IV of 1989), in section 3,-

- (a) in sub-section (1), in clause (a), before the words "Provincial Assembly", the words "National Assembly and" shall be inserted; and
- (b) in sub-section (3), after the words "one of the members", the words, commas, alphabet, brackets, hyphen and figure, "", at clause (a) of sub-section (1)," shall be inserted.
