STANDING ORDER NO. 3 / 2007.
ALLOCATION, UTILIZATION AND DRAWAL OF FUNDS UNDER THE
HEAD " COST OF INVESTIGATION"

1. INTRODUCTION

In exercise of power vested under Article 10 (3) of the Police Order 2002, the Standing Order is issued for regulating the allocation, utilization and drawl of the funds under Cost of Investigation

2. AIM

1. Regulating allocation of funds for the cost of Investigation.
2. Streamlining the drawl of the funds for the cost of Investigation and avoiding its misuse.
3. Plugging chances of corruption by providing fool-proof accountability.

3. APPLICABILITY

1. The Standing Order is issued in supersession of Standing Order No. 6 of 2002 and shall come into force with immediate effect.
2. It shall apply to all the Officers of District Police and investigation Branch engaged in investigation of cases.

4. ALLOCATION OF FUNDS

FORMULA

$$\frac{\text{Last Year Crime of the District} \times 100}{\text{Last Year Crime of Province}} = \text{Average}$$

The funds of District shall be calculated on the basis of average of crime and accordingly, share shall be allocated to District. 20% of the allocated share shall be fixed for preventive staff in connection with investigation of cases under the Local & special Law punishable with imprisonment not exceeding 3 years.

5. PROCEDURE

The investigation has been separated from Watch & Ward with view to improve the Standard of Investigation and make it a specialized cadre. Therefore, the Government provides sufficient funds as cost of investigation which are required to be properly and justifiably allocated utilize and draw. As such it is laid down that drawl of the funds shall be permissible in cases indicated in the schedule attached hereafter.

The expenditure shall be incurred by the investigation Officer and approved/sanctioned by Incharge investigation/DPO of the District, as the case may be which will be drawn from the Accountant General/DAOs as contingent bills, in accordance with the existing procedure under the delegation of Powers Rules 20% of the funds will be paid to the Watch & Ward shall for investigation of cases of local and special laws punishable with imprisonment not exceeding three years.

The account of such expenditure will be kept by DDOs which will be consolidated in the Office of Additional Inspector General of Police, Investigation, NWFP, Peshawar. Reconciliation of such accounts at District level shall be carried out by the DDOs, while centrally the re-conciliation of the consolidated figures will be done by Additional Inspector General of Police, Investigation, NWFP, Peshawar.

6. AUDITS

The account will be subject to annual audit by AG Office as well as by the local Auditors under the supervision of Deputy Director Accounts.

The Budget provision for the cost of investigation has been made under a separate Head, viz 6-22200-Provincial Police 13, separation of investigation from Law & Order including prosecution. 59910-104 cost of investigation.

7. PUNISHMENT

Violation of this order shall be punishable departmentally whereas misappropriation and misuse of funds shall be liable under the relevant sections of PPC and Prevention of Corruption Act.

8. AREAS/EXTENT FOR UTILIZATION OF FUNDS

- i. Spot visit/preparation of site plan, preservation of spot including video/photography, collection of evidence/identification of property.
- ii. Charges for dead/injured persons for medico-legal examination and photography if required.
- iii. Sealing of parcels and its dispatch to FSL and return.
- iv. Arrest of accused/production in court for remand, confession/ identification and meals/ fare of the accused.
- v. Proclamation through print media if required.
- vi. Purchase of stationery/chemicals.
- vii. Cultivation of informers/collection of intelligence.
- viii. Unforeseen.
