Dear Sir,

This is in reference to your letter # 9327/25/9-PA/IND-VOL-III dated 04-12/2024 on the subject cited above.

In this regard, reply to the questions raised by MPA are as follow:-

1. Yes, Lucky Cement Ltd is situated in District Lakki Marwat & only using the raw material i.e Limestone & Clay, rest of the material are supplied from other Districts.
2. It is not correct that Lucky Cement is the cause of spreading diseases in District due to dust emission of the Plant. Lucky Cement has installed State of the art Dust collecting system Plant i.e Bage House & Filters. The main purpose & function of this system is to control Dust emission & as such, no dust is emitted from the Plants of Lucky Cement. EPA, which is the sole controlling authority for inspection of dust emission, has inspected our Plant from time to time.
3. The facilities & payments to the Govt are as follow:-
 - i. Lucky cement is paying 80 to 100 Million rupees monthly to the Provincial Govt on account of Royalty.
 - ii. In addition to this Lucky cement is paying 3 to 4 Million on account of Excise duty & Electricity duty to the provincial exchequer monthly.
 - iii. Lucky cement has paid 272.8 Billion rupees on account of different Taxes to the Central Govt exchequer since 2009. Detail attached.
 - iv. Lucky Cement is paying surface rent to the local landowners as compensation for using their land.
 - v. Lucky cement is spending an amount of Rs. 181.7 Million annually on the welfare of local community.
 - vi. Lucky cement has established Two English medium Primary & Secondary Schools for the local people where free education facility is available to everyone.
 - vii. Lucky Cement has established a Dispensary for the local peoples, where a Doctor & Lady Doctor are available & free medicine is available to the patients.

- viii. Lucky Cement has constructed 12 Solarized pressure pumps in the outskirts of Pezu Plant.
- ix. Lucky cement has installed 05 Solarized Tube well for the welfare of locals in District Lakki Marwat.
- x. Lucky cement is giving 06 month paid internship to the 20 local graduate engineers per year of Lakki District.
- xi. Lucky Cement is providing free internship to all the local Diploma holders & engineers.
- xii. Lucky Cement is granting 20 Scholarship to the 1st & 2nd year student per year.
- xiii. Lucky cement is paying hardship allowance to all the low paid employees & Labours alongwith free ration every month.
- xiv. Lucky cement has donated books & Computer Lab to GHSS Shahbaz Khel.
- xv. Lucky cement has installed Water supply scheme at the cost of Rs.10 Million for people of village Pezu.
- xvi. Lucky cement is providing free vocational training to the student of District Lakki Marwat every year.
- xvii. Lucky Cement has installed a Solarized Tube well for the people of village Jogi.
- xviii. Lucky cement has established a nursey at the cost of 03 Million where free plants are distributed among the locals every year.

We hope that this is suffice to satisfy the worthy MPA with the assurance that Lucky Cement will endeavor for the uplifting of Local community in every way & assure our best possible Co-operation at all times & hope that your kind support and good understanding in the subject matter will be honour for us please.

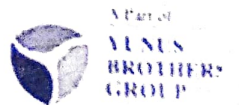
