Subject: - **JOINT RESOLUTION No.120 ADOPTED BY THE PROVINCIAL**
ASSEMBLY OF KHYBER PAKHTUNKHWA.

Dear Sir,

I am directed to say that the Provincial Assembly of Khyber Pakhtunkhwa in its sitting held on **13-01-2025** passed unanimously the following joint Resolution No. **120** moved by Mr. Ahmad Kundi, Mr. Adnan Khan and Mr. Makhdoom Zada Muhammad Aftab Haider, Members Provincial Assembly Khyber Pakhtunkhwa as follows:-

“Whereas after merger of erstwhile FATA, the Levis & Khasadar Force was absorbed in KPK Police through **Khasadar Force Act 2019**, and **Khasadar Force (absorption in Khyber Pakhtunkhwa Police) Rules 2019**, made under section 5 of the said Act and notified vide Government of Khyber Pakhtunkhwa, Home & Tribal Affairs Department **Notification No. SO (Police-II) HD/SMY 2019 dated 24-09-2019.**

And whereas the rules ibid, were further amended by the Department concerned vide **Notification No. SO (Police-II)HD/SMY 2019 merged areas/919-26 dated 15-06-2020** under section 10 of the aforementioned Act, which does not fulfill the absorption criteria as a whole, as the same has been practically implemented under the Act but has not been covered in the rules as mentioned above.

Therefore, this Assembly strongly recommends to the Provincial Government that the following amendments may be made in the said rule to avoid any discrimination/disparity amongst the employees absorbed through the said Act:

1. in sub-rule (2), of rule 3, after the word and comma “iwazis,” the words and comma “or other persons,” may be added; and
2. in rule 3 (b), in the schedule, the posts “Resaldar, Jamadar, Dafadar etc” may be added in the said rules”

You are, therefore requested that action taken on the resolution may be intimated to this Secretariat within a period of two months from the date of its communication under sub-rule (3) of Rule 135 of the Provincial Assembly of Khyber Pakhtunkhwa Procedure and Conduct of Business Rules, 1988 for circulation amongst the Members of the Assembly.
