I am directed to say that the Provincial Assembly of Khyber Pakhtunkhwa in its sitting held on 17-02-2025 passed unanimously the following Resolution No. 143 moved by Mr. Ikram Ullah, Member Provincial Assembly of Khyber Pakhtunkhwa as follows:-

ہر گاہ کہ بتاریخ 14 جنوری 2025 کو وزیر اعلیٰ خیر بختونخوا کے زیر صدارت بورڈ آف ڈائریکٹرز کا اجلاس ہوا جس میں ٹورازم پولیس اہلکاروں کو ریگولر کرنے کا فیصلہ کیا گیا اور انہی اہلکاروں کی تنخواہ 36000 سے بڑھا کر 45000 روپے کرنے کی منظوری بھی دی گئی لیکن بعد ازاں مذکورہ بالا فیصلے پر متعلقہ ٹورازم و کلچر اتھارٹی نے ابھی تک عمل درآمد نہیں کیا اور ٹورازم پولیس اہلکاروں کا کنٹریکٹ بھی عنقریب ختم ہونے والا ہے۔
لہذا یہ اسمبلی صوبائی حکومت سے سفارش کرتی ہے کہ وہ ٹورازم پولیس اہلکاروں کو ریگولر انز کرنے کے ساتھ ساتھ ان کی تنخواہ کو بھی 36000 سے 45000 روپے کرنے کے احکامات جاری کریں۔
