





ACT

further to amend the Shariah Nizam-e-Adl Regulation, 2009

WHEREAS it is expedient further to amend the Shariah Nizam-e-Adl Regulation, 2009 (Khyber Pakhtunkhwa Regulation No. I of 2009);

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

1. **Short title and commencement.**---(1) This Act may be called the Khyber Pakhtunkhwa Shariah Nizam-e-Adl Regulation (Amendment) Act, 2024.

(2) It shall come into force at once.

2. **Amendment of section 6A of the Khyber Pakhtunkhwa Regulation No. I of 2009.**--- In the Shariah Nizam-e-Adl Regulation, 2009 (Khyber Pakhtunkhwa Regulation No. I of 2009), in section 6A, in sub-section (1), for the second proviso, the following shall be substituted, namely:

“Provided further that Government may, from time to time, extend the tenure of the Muavineen-e-Qazi, subject to their performance, for such time as it may deem appropriate.”.
