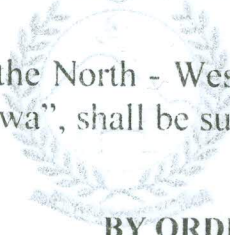

**WHEREAS** it is expedient further to amend the Institute of Management Sciences Ordinance, 2002 (N.W.F.P Ordinance No. XXXVII of 2002), for the purposes hereinafter appearing;

It is hereby enacted by the Provincial assembly of Khyber Pakhtunkhwa as follows:

- 1. Short title and commencement.**---(1) This Act may be called the Institute of Management Sciences (Amendment) Act, 2025.  
(2) It shall come into force at once.
- 2. Amendment of section 10 of the Khyber Pakhtunkhwa Ordinance No. XXXVII of 2002.**--- In the Institute of Management Sciences Ordinance, 2002 (N.W.F.P Ordinance No. XXXVII of 2002), in section 10, sub Section (1), in clause (i),

for the words "Governor of the North - West Frontier Province", words "Chief Minister, Khyber Pakhtunkhwa", shall be substituted.
