Bill**

*to re-constitute the Trade Testing Board established under the  
National Training Ordinance, 1980.*

**WHEREAS** it is expedient to re-constitute the Trade Testing Board established in the Province of Khyber Pakhtunkhwa under the National Training Ordinance, 1980 to assess and certify the youth acquiring their technical and vocational skills through formal or informal establishments and institutes of the Province of Khyber Pakhtunkhwa imparting trainings in various trades and occupations affiliated for the purpose related thereto;

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

**1. Short title, extent, application and commencement.**---(1) This Act may be called the Khyber Pakhtunkhwa Trade Testing Board Act, 2025.

(2) It shall extend to the whole of the Province of Khyber Pakhtunkhwa.

(3) It shall apply to all establishments and institutes in the Province of Khyber Pakhtunkhwa engaged in imparting technical and vocational trainings in the trades mentioned in the Schedule.

(4) It shall come into force with effect from 30<sup>th</sup> November, 2021.

**2. Definitions.**---In this Act, unless there is anything repugnant in the subject or context,-

- (a) **“assets”** means anything of value which includes but is not limited to property whether tangible or intangible, cash, investment, accounts, receivables, loans granted, inventory, real estate, machinery, contracts, licenses, permissions trademarks, copy rights, patents, approvals of the Trade Testing Board or otherwise anything that can be beneficial to or can be used for the benefit of the Board for the performance of its functions under this Act;
- (b) **“Board”** means the Khyber Pakhtunkhwa Trade Testing Board re-constituted under section 3 of this Act;
- (c) **“Chairperson”** means the Chairperson of the Board;
- (d) **“Department”** means Industries, Commerce and Technical Education Department of Government;
- (e) **“employees”** mean the employees of the Board appointed under section 6 of this Act;



- (f) **“establishment”** means any office, firm, industrial unit, undertaking, workshop or premises in which workforce are employed for the purpose of carrying on any industry;
- (g) **“Fund”** means the Khyber Pakhtunkhwa Trade Testing Board Fund established under section 8 of this Act;
- (h) **“Government”** means the Government of Khyber Pakhtunkhwa;
- (i) **“institute”** means any school, college, institute by whatever name called, imparting technical or vocational training;
- (j) **“industry”** means any business, trade, manufacturer, calling service, employment or occupation;
- (k) **“prescribed”** means prescribed by rules or regulations made under this Act;
- (l) **“Province”** means the Province of Khyber Pakhtunkhwa;
- (m) **“record”** means any information, documents, ledgers, books, answer sheets, award lists, accounts, data in hard and soft form, dossiers, files, reports, archives, notes, minutes, transactions, proceedings, transcripts, certificates, deeds, instruments, diaries, logs, inventory lists, catalogues, case files, case studies or otherwise anything that is relevant or pertaining to the Board or that may be deemed as record of the Board;
- (n) **“regulations”** mean regulations made under section 14 of this Act;
- (o) **“Repealed Ordinance”** means the National Training Ordinance, 1980 (Ordinance No. IX);
- (p) **“rules”** mean rules made under section 13 of this Act;
- (q) **“Schedule”** means the Schedule appended to this Act;
- (r) **“Secretary”** means the Secretary of the Board; and
- (s) **“trade”** means a trade mentioned in the Schedule.

### 3. **Re-constitution of the Khyber Pakhtunkhwa Trade Testing Board.**---(1)

As soon as may be after the commencement of this Act, the Government shall by notification in the Official Gazette, re-constitute the Trade Testing Board established under the provisions of the Repealed Ordinance and shall be known as the Khyber Pakhtunkhwa Trade Testing Board.

(2) The Board as reconstituted and re-named under sub-section (1), shall be a body corporate, having perpetual succession and a common seal with powers, subject to the provisions of this Act, to acquire, hold and dispose of property, both movable and immovable and may by its name sue and be sued.

(3) The head office of the Board shall be at Peshawar, however, the Board may establish its regional offices at such places in the Province as it may deem fit.

(4) The Board shall consist of the following, namely:

(5) The members at clauses (k) and (m) of sub-section (4), shall be appointed by the Chairperson of the Board for a period of three years.

(6) The members at clauses (k) and (m) of sub-section (4), may resign from their office by tendering resignation in writing to the Chairperson:

Provided that unless his resignation is accepted by the Chairperson of the Board, the member shall continue to act as member of the Board.

(7) The members at clauses (k) and (m) of sub-section (4), may be removed from membership of the Board on any of the following grounds, after giving them an opportunity of being heard, namely:

- (a) he has become mentally or physically so incapacitated as to render him unable to perform his duties as member;
- (b) he has been convicted by a court of competent jurisdiction for an offence involving moral turpitude;
- (c) he is involved in corruption or corrupt practices;
- (d) he has become insolvent or bankrupt or has been declared so by the court of competent jurisdiction; or
- (e) he has remained absent from three consecutive meetings of the Board without any intimation or cogent reasons to the Chairperson.

(8) If a vacancy occurs in the composition of the Board due to resignation, death or removal of a member, the Chairperson shall appoint another person as member of the Board to fill the vacancy till the remaining period of the term:



Provided that no proceeding of the Board shall become invalid merely by reason of any vacancy or absence of a member therefrom unless the quorum is validly complete.


**4. Functions of the Board.**---(1)The Board shall exercise the following powers and functions, namely:

- (a) affiliate any kind of skill development center, industrial unit, workshop, organization, firm and vocational training center by whatever name called, imparting skill development, vocational and professional training in the trades mentioned in the Schedule and award certificates in the said trades as per manual of National Vocational Qualification Frame Work (NVQF) courses in the province or any other region and guidelines issued by National Vocational and Technical Training Commission (NAVTTC) in this regard from time to time;
- (b) register the enrolled trainees in the affiliated training centers, institutes, schools, colleges, workshops and industrial units etc. for their assessment and certification;
- (c) develop system and conduct trade testing and certification of skilled workers who have received vocational training through any source or acquired skills through experience or informal system;
- (d) implement policies pertaining to affiliation, student registration, assessment and certification of trades mentioned in the Schedule;
- (e) approve the financial plans and annual budget of the Board;
- (f) constitute committees for carrying out the purpose of this Act;
- (g) create, re-designate upgrade and abolish posts on need basis:

Provided that while creating posts the financial implication shall not exceed the approved annual budget;

- (h) fix and receive such fees as may be prescribed;
- (i) hold, control and administer its assets and funds;
- (j) adopt reforms initiatives in skill development and trades as given in the Schedule; and
- (k) act or perform any function under this Act or any other related function assigned by the Government to the Board from time to time.

(2) The Functions of the Board under sub-section (1) relating to approval of financial plans, approval of budget, adoption of reforms initiatives, creation, re-

designation or abolition of posts, fixation of fee and control and administration of assets shall be subject to approval of the Minister/Advisor/ Special Assistant to the Chief Minister on Industries, Commerce and Technical Education, as the case may be.

**5. Meetings of the Board.**---(1) The meetings of the Board shall be held at least once in three months, as and when required, at such time and place as the Chairperson may determine.

(2) Meetings of the Board shall be regulated in the manner, as may be prescribed.

(3) Meetings of the Board shall be presided over by the Chairperson. In case the Chairperson is not available, another member, nominated by the Chairperson, shall preside over the meeting.

(4) Decisions of the Board shall be made by the majority of votes and in case of tie, the Chairperson shall have the casting vote.

(5) Nine members of the Board shall constitute quorum of the meeting.

**6. Employees of the Board.**---(1) The Board may, for the efficient performance of its functions, appoint such employees on regular basis and on such terms and conditions, as may be prescribed by the regulations.

(2) The Board may appoint such number of advisors, consultants or other employees temporarily on contract basis and on such terms and conditions as may be prescribed by the regulations.

**7. Employees of the Board to be public servants.**---The employees of the Board and other persons appointed for carrying out the purposes of this Act shall be deemed to be public servants within the meaning of section 21 of the Pakistan penal Code (XLV of 1860).

**8. Fund of the Board.**---(1) There shall be a Fund of the Board to be known as the Khyber Pakhtunkhwa Trade Testing Board Fund.

(2) The Fund shall consist of the following, namely:

- (a) fees collected on account of affiliation of institutes, students registration, assessment, verification and certification of trainees;
- (b) endowments, grants and contributions from individuals or philanthropic organizations whether national or international;
- (c) loans obtained by the Board from any bank or financial institution;
- (d) grants-in-aid by Government or the Federal Government; and



- (e) income from any legal source, including investment of any surplus funds or deposit thereof in a bank on competitive markup rates as per Government policy.

(2) The accounts of the Board shall be maintained in such a manner as may be prescribed.

**9. Budget of the Board.**---The budget of the Board shall be prepared in the prescribed manner each year and shall be placed before the Board for approval.

**10. Audit and account.**---(1) The Board shall maintain the accounts of receipts and expenditure in such manner as may be prescribed.

(2) The statement of accounts of the Board shall be submitted to Government once a year in the prescribed manner.

(3) The statement of accounts of the Board shall be submitted to the Government at the close of each financial year in such manner, as may be prescribed.

(4) Audit of accounts of the Board shall be carried out by Director Local Fund Audit.

**11. Delegation of powers.**--- The Board may delegate any of its powers, duties or functions to any of its member or officer in such a manner, extent and period, as may be prescribed by regulations.

**12. Assistance to Board.**---All Government entities, agencies, Departments and institutions of Government shall assist the Board in the discharge of its functions as and when such an assistance is requested by the Board.

**13. Power to make rules.**---The Government may make rules for carrying out the purposes of this Act.

**14. Power to make regulations.**---The Board may make regulations, not inconsistent with this Act and the rules, for carrying out the purposes of this Act.

**15. Indemnity.**---No suit, prosecution or other legal proceedings shall lie against any person for anything done or intended to be done in good faith under this Act.

**16. Power to amend Schedule.**---The Board may, from time to time by notification in the Official Gazette, amend the Schedule.

**17. Transfer of assets, record, liabilities and other ancillary matters to the Board.**---All assets, liabilities, bank accounts, claims, proceedings before any mediators or any Tribunal whether judicial or quasi-judicial along with necessary records in so far as pertaining to the statutory and administrative functions of the Trade Testing Board established under the Repealed Ordinance, shall henceforth vest in the Board to the extent of trades mentioned in the Schedule.



**18. Transfer of employees to the Board.**---(1) Notwithstanding anything contained in any law for the time being in force, all the regular employees of Trade Testing Board established under the Repealed Ordinance shall stand transferred to, and become employees of the Board.

(2) The seniority of these employees shall be settled from the dates of their appointment and shall stand protected.

**19. Repeal and savings.**---(1) The National Training Board Ordinance, 1980 (Ordinance No. IX of 1980) is hereby repealed to the extent of the Province of Khyber Pakhtunkhwa.

(2) Notwithstanding the repeal of the aforesaid Ordinance, anything done, actions taken, rules made, notifications or orders issued under the aforesaid Ordinance, till the commencement of this Act, shall, in so far as, such actions, rules, notifications or orders are not inconsistent with the provisions of this Act, be deemed to have validly been done, taken, made or issued under this Act and shall have effect accordingly.

(3) Any document referring to the provisions of Repealed Ordinance shall be construed as referring to the corresponding provisions of this Act.

### **STATEMENT OF OBJECTS AND REASONS**

Trade testing is an important process that ensures that individuals in the society possess necessary skills and technical knowhow and competencies to perform a specific trade or profession/occupation. Individuals with technical knowledge and professional skills play a vital role in national development and supports economic growth as on the one hand professional/technical individuals are self-dependent and on the other hand they have the potential of employing others and spreading their skills.

The trade testing is an area that promotes quality of workmanship and ensures that the skilled worker delivers excellent services. Trade testing also contributes to producing skilled and competent workforce which is fundamental to economic growth and development. It also helps in documenting informal technical expertise in different fields/trades thus encouraging development and growth of different trades in informal sector.

Trade testing encourages persons with expertise in different trades to continuously update their skills and knowledge in order to maintain their certification. It also helps trades experts to stay current with the developments, best practices and new technologies in industry.


The existing Trade Testing Board in Khyber Pakhtunkhwa was established under the National Training Ordinance, 1980 to assess and certify the youth acquiring their technical and vocational skills through formal or informal establishments and institutes of the Province of Khyber Pakhtunkhwa imparting trainings in various trades and occupations affiliated for the purpose related thereto. In the year 2021 the Ordinance ibid was repealed due to reason that the subjects of trade testing, technical and vocational education were provincialized in wake of 18<sup>th</sup> Constitution Amendment. The repeal of the Ordinance ibid created a legislative and statutory



vacuum as regards Trade Testing Board in the Province and its activities/certifications in different trades.

It is, therefore, expedient to have a provincial legislation on the subject in the best public interest and to re-constitute the already established Trade Testing Board under the new Provincial law.

The draft Bill seeks to achieve the above mentioned objectives.
